PAYOUT POLICY

The Associates Earnings are determined based on their growth in the Business Fulfillment plan, upon their fulfillment of each plan's qualification criteria that has been defined through business support materials and website content.

The Retail profit awarded through the Business Fulfillment plan is determined based on the business value of the product the Associate has purchased and registered in their E-office.

The Generation income distributed through the Business Fulfillment plan is determined based on the business volume of the Jumpstart Product Package the Associate has purchased and registered in his/her E-office.

The Position bonus distributed through the Business Fulfillment plan is determined as per the criteria defined for a certain position and whether or not the Associate has fulfilled it. The Associate has the freedom to determine at what pace they would like to fulfill the criteria.

The Introducer bonuses distributed through the Business Fulfillment plan are determined as per the business volume of the Retail product or Jumpstart product package carries.

The Associate will earn commissions through their Cashback website purchases only when the company receives the confirmation of purchase made from the Associate and any commission from the sale website.

The Company shall determine whether a payout made through the Business Fulfillment plan shall be trimmed.

REFUND, EXCHANGE & BUYBACK POLICY

DRPF Worldwide offers a 30 day exchange in the form of a coupon if they are intimated by the Associate in writing to the official DRPF Worldwide email address with proof of product purchase and date of purchase. Exchange will be processed once goods are received at the point of sale (Fulfillment Center).

Product delivery shall take any where from seven to fifteen working days once the payment has been successfully processed.

Products purchased through the E - Store, Fulfillment Center, Associate shall be exchanged in case of any damage and/or manufacturing and/or packaging defects within 30 days of product delivery.

All exchanges for product(s) that have been purchased from an

Associate shall be executed through the Associate respectively. All exchanges for product(s) purchased from the E-Store or picked up at a Fulfillment Center shall be executed through the Company or Fulfillment Center respectively.

All exchanges shall be fulfilled upon the customer presenting the product(s) in question along with the official DRPF Worldwide receipt issued to them at the time of product dispatch.

Product exchange shall not be entertained for products that have been opened and / or used and / or after 30 days of product delivery.

Associates are encouraged to purchase product(s) that they shall use and / or sell within a month. The Company offers a buyback policy only to Associates who wish to resign from their DRPF Career, upon the Company's discretion, that the quantity and/or value of product(s) that the Associate had previously purchased caused a financial burden to the Associate.

The Associate should contact the Company regarding a buyback if the product(s) have an expiry date that is six months or prior from the day the Associate contacts the Company. The Associate must have all original bills of purchase and unopened,
